DECLARATION

No child under 16 years of age will be allowed to leave the activity unless collected by a known adult, or unless prior agreement as been given by parent / guardian.

The parent/guardian will:

- a) Deliver the Junior Activity Member to the activity at the appropriate time as notified by the Club,
- b) Collect the Junior Activity Member from the activity promptly at the end of the activity,
- c) Give prior notice to the Coach if anyone other than the signatory be collecting your child,
- d) Ensure that any medication provided is clearly labelled with the child's name and dosage instructions.

The parent/guardian agrees that the Junior Activity Member shall abide by the rules of the Club and accepts that the Junior Activity Member may be expelled from the Club following a serious breach of those rules, for the display of unacceptable behaviour towards the coach, the Club employees or other members.

Junior Activity Membership Rules

(To be read in conjunction with the main Club rules and byelaws)

1. Junior Activity Membership shall have two categories: (A) 5 to 8 years old, and (B) 9 to 17 years old. Categories are in line with the Children's Act.
2. For Category (A) members an Responsible Adult must remain on the Club's premises at all times when the Junior Activity Member is present on the Club site. For Category (B) members under 16 years of age an accompanying adult must deliver, register and collect the Junior Activity Member. Responsible Adults must provide the activity coach with a telephone number by which they can be contacted at any time while the Junior Activity Member is at the Club's premises.
3. Each Junior Activity Member will be issued with a membership card which must be available for inspection at any time by an officer of the Club. Junior Activity Members will have no voting rights and are not permitted to sign in guests.
4. For each activity in which the Junior Activity Member participates, the Responsible Adult must deliver a Junior Activity Member under 16 years of age to the activity coach and register him/her for that session. For Category (B) members, the accompanying adult may leave the premises but must return at the appointed time to collect the Junior Activity Member.
5. Junior Activity Membership is only valid for the duration of the activities for which the Junior Activity Member is registered. Outside of activity times, juniors may be on Club premises only with an accompanying adult who is a Member of BA Clubs.
6. The fee for Junior Activity Membership shall be £15 per annum. Junior Activity Members may register for and join in any amount of junior activities that are on offer by the Club. Appropriate fees will be charged for each activity in addition to the Junior Activity Membership subscriptions. Junior Activity Members over 14 years of age may also participate in section activities on payment of the appropriate fees to the relevant section.
7. No coaches, staff or volunteers will be allowed to supervise junior activities unless they have passed the appropriate CRB check and provided the relevant Qualification and Governing Body Membership Certificates to the Club.
8. Coaches will provide accompanying adults with details of dropping off, registration & collection procedures and take the necessary contact details.
9. On being admitted to membership, parents/guardians of Junior Activity Members must provide to the Club all relevant medical details relating to the Junior Member prior to commencement of any sporting activity. Medical details will remain strictly confidential between the Club, the coach and the parent/guardian.
